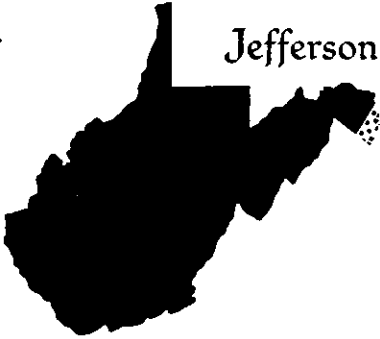


WHEREAS, the Jefferson County Planning Commission has concluded that certain amendments are needed in the Improvement Location Permit Ordinance, and

AMENDMENTS TO THE
JEFFERSON COUNTY IMPROVEMENT LOCATION PERMIT ORDINANCE

Section 4.1 Forms, Fees, Processing -- The first paragraph shall be deleted and replaced with the following:

Application forms and such material as may be necessary to administer the Improvement Location Permit Ordinance shall be prepared and distributed by the Planning Commission. The application fees for an Improvement Location Permit shall be set by the County Commission of Jefferson County, upon recommendation of the Planning Commission, as may be necessary from time to time in order to defray the cost of administering this Ordinance.
