#### From the Assessor-Lisa Freeman

All townships and cities in Allegan County were audited this year using the 2023 assessment information. An audit is conducted every five years to determine if each unit is complying with the State's standards for assessment administration. For this particular audit, they look at how land values and economic condition factors are calculated and applied as well as review policies the township has in place for handling a variety of situations. Overisel Township was determined to be compliant on how property is valued in the township.

This fall I will send out a *Residential Review* to 20% of property owners in the township. If you receive a *Review*, please look it over carefully for any errors. A stamped envelope is included to return the *Review* to the office. Corrections may be made by writing on the *Review* or emailing or calling the assessor. After the *Residential Review* is mailed, I will conduct a visual inspection by driving to your home. Often, I can update the photo of your property from the road, however, for those of you who have long driveways or a lot of trees, I will take the photo from the driveway. I usually do not get out of my car to take a photo. If you have any questions, or concerns, about this, please contact me.

- \*\*Handled pails need to be picked up by October 15. Any pails left will be put in the building at the cemetery. In the spring they will be put outside.
- \*\*We would like to standardize the flower pot holders so please use only the metal ones with a **handle**.
- \*\*The caretakers are asking if you leave a memory item on the grave, that you please come back in a timely manner and remove the item(s). Caretakers are not responsible for items left and have the authority to remove items in a timely manner.

Permits (Building, Electrical, Plumbing, Mechanical) are required for all construction (new building, remodeling, furnaces, water heaters, etc.) New homes on agricultural property need a Special Use Permit from the Planning Commission. All AG buildings need a Zoning Compliance Permit. Permit

It is the owner's responsibility to make sure their taxes are paid.

Recycle Bins are located at the Twp. Hall. The "single stream" means no sorting. Glass, paper, metal cans, plastic, flattened cardboard are accepted. NO TRASH! (Please use Paper Gators for paper, located at Oakland CRC, Overisel RC, Bentheim Elem. School. Tax money pays to recycle paper. These groups benefit and no tax money used. A win-win.)

Burn Permit reminder-The permit is only good for burning brush, shrubs, and leaves. It is valid for the day you call it in. You must have a water source nearby. If the burn gets out of control, call 911. Illegal burn fines will be based on the time and material it takes to put out the fire.

Twp. Hall is open every Tuesday from 9-5.

Junk Ordinance-We continue to get complaints about properties that are in violation of this ordinance. Please clean up your property. Vehicles need to be licensed and drivable to be parked on your property. If they are not, they need to be removed or parked indoors.

Transfer Station is open from 8 AM-1 PM on the first and third Saturday of each month (closed January and February). You must buy a card which can be bought at the Transfer Station for \$20.00. It is located 1/4<sup>th</sup> mile north of Sandyview School on 46<sup>th</sup>.
