Call to Order: Supervisor Russ Van Dam called the meeting to order at 7:30 pm and he opened with prayer.

Members Present: Russ Van Dam, Pat Reuschel, Renee Hop, Tom Flokstra and Harv Jipping.

Al Co Commissioner: Jim Storey gave an update on county activities. Amanda from Lakeshore Advantage gave an update.

 6. A motion was made by Reuschel and supported by Jipping to pay the bills as presented. Motion Carried.
