HAZARDOUS WASTE/TV/ COMPUTER RECYCLE EVENT:

Allegan County Resource Recovery is hosting a Regional <u>Household</u> Hazardous Waste/TV/Computer Recycling Event at the Allied Waste Recycling Station. (See date, location and time on page 1). All materials received at this event will be recycled or properly disposed of by certified vendors that strive in protecting the environment. This is a great way to responsibly clean-out the garage, pole barn or basement.

Heath Township residents can drop off acceptable materials (detailed on page 1) at this event. Please present your Resource Recovery Card that is in with your winter tax receipt information to confirm eligibility.

Heath Township Curbside Recycling

Residents can participate in a curbside recycling program through the township. Recyclables are collected by Republic Services on the first

Wednesday of each month. When the regularly scheduled collection day falls on or after a holiday in that week, service will be provided one day later.

Materials must be set out the night before collection. This service is for residential homes only.

To sign up for this valuable program, please go to the Township Hall during office hours or call Allegan County Resource Recovery at 269-686-4559. (This service is funded by the \$25 surcharge on the winter tax bill.)

*Missed Customers/Weather Delays:

Please contact Resource Recovery if you were missed on the regular scheduled pick-up day. Any weather related delays will be posted to the website referenced on the bottom of this page.

The following recycling items can be comingled together: Plastic bottles and containers, metal cans, clear and colored glass, newspapers, paper, cardboard and magazines. Items must be clean! If your cart is not large enough to accommodate your recycling needs, remember that this material can be dropped off at the Allied Waste Recycling Station listed below.

As we look to the future, we continue to see improving working relationships with our surrounding Fire Departments. Many times in discussions with the other Chiefs the topic of how can we better service our community together comes up. Finding ways to share resources is the common goal.

Please remember to change your smoke detector batteries. Working smoke detectors save lives. A few weeks ago Hamilton Fire ran a call of a house fire. She opened the door to the garage, saw flames, and called 911.

Please review the attached Burning Ordinance for Sections 5 & 6 in Heath Township.

If you have rental property in those Sections you must inform your renters. You will be billed as the property owner. As the weather gets nicer there will be no exemptions to the Ordinance. Please follow the Township Clean Up Day for dumpster usage.

Heath Township Burning Ordinance

Adopted: September 8, 2003 Effective: October 17, 2003

Amendment Adopted: August 9, 2004 Effective: August 17, 2004

No open burning shall be permitted in Sections 5 and 6 of Heath Township, Allegan County, Michigan. However, a resident in Section 5 or 6 may apply to the Hamilton Fire Chief or designated officer to obtain a special permit for open burning or campfires. This permit request must be in written form. Residents may apply for a seasonal campfire permit as long as they have an approved fire ring. In consideration of any permit, adjoining property owners must be notified by an applicant. Open burning and campfires in other sections of the Township shall be governed by the provisions of Section IV.

Section IV **Provisions for Open Burning**

All open burning, as in out-of-doors burning on the ground, shall comply with the following provisions:

- 1. Be attended by a competent person at all times.
- 2. Burning to occur only after sunrise and extinguished and admitting no smoke after 9 p.m. or 10 p.m. during daylight savings time.
- 3. Burning shall occur at least fifteen feet (15') from any structure, fencing or woodpiles.
- 4. Burning shall occur at least fifteen feet (15') from any public or private property line.
- 5. No burning shall occur within a 24 hour period proceeding and during any Trick-or-Treat hours established by the Township Board.
- 6. No burning shall occur if it is determined by the Fire Chief that conditions are such that burning would be hazardous to health, safety, and general welfare of the citizens of the community.

Enforcement and Penalties

The enforcement of this ordinance and regulations established by the Township Board shall be performed by such person or persons as the Township Board designate by resolution. Any person, partnership, firm, association or corporation who shall fail to comply with the rules as defined and set forth in this ordinance, shall be deemed responsible for the municipal civil infraction as defined by Michigan Statue which shall be punishable by a civil fine determined in accordance with the following schedule:

1st Offense within 2 year period* \$100.00 2nd Offense within 2 year period* \$250.00 3rd Offense within 2 year period * \$500.00

Assessment News

Another assessing cycle has passed and you will soon be receiving your 2016 tax bills. Since Proposal A passed in 1994 your taxes are based on taxable value not the assessed value. Assessed value changes based on the real estate market, new construction on your property or any other changes made to your property.

Taxable value changes by the previous 12 month consumer price index or 5% whichever is less. It also changes by anything new added to your property or by the sale and purchase of your property. For 2016 the consumer price index is 1.003% so you should see about a 1.003% increase in your taxes unless millage rates change.

The taxable value is controlled by State Law and cannot be changed by the Board of Review or Assessor unless the assessed value goes below the taxable value.

The Township has added an assistant to the assessor. We will be continuing to do site visits to properties on a regular basis to try to eliminate inequities and comply with State Law. We will notify you prior to the visit to your property. For your information her name is Lisa Freeman, so if she contacts you by mail or phone please work with her as we need to do this process based on State of Michigan requirements. As time passes Lisa will be transitioning to the Township Assessor. This will be phased in over the next year.
