# Heath Township Meeting Minutes December 2021

#### 1. Call to order

# 4. Reports

- a) Jim Storey, County Commissioner gave his monthly report:
- Discussed Commissioner Board Meeting and updates and rule changes
- Discussed the new building is close to being done with construction and being open to use
  - b) Bob Genetski, County Clerk, gave a summery on the Annual report for 2020 from the Allegan County Clerk and Register of Deeds.
  - c) Amanda Moore, Therapist from Safe Harbor Children's Advocacy Center in Allegan County, gave a synopsis of what the Center does in Allegan County and talked about the new facilities they are trying to build and looking for some additional funding from Townships in hopes of achieving this for their growth.
  - d) Missy, Township Clerk, reported that the Township has grown in size of registered voters and has now gotten to the point of establishing another precinct.
  - e) Hilda, Trustee, reported that she spoke with the Sheriff's Department about the fireworks that are being shot off and the Sheriff said that they want residents to call 911 when this occurs so they can send a unit and have a report on record. Also it was noted that these fireworks were not being lit in Heath Township. Hilda also reported on the survey from Brookside cemetery and looking for the deed on record for this cemetery.

A site plan was submitting by Top Grade for a sand pit on 132<sup>nd</sup> St and 38<sup>th</sup> St. The Planning Commission Board is waiting for the Resolution from the planner to be updated with the changes they made. Once that is done, it had been approved by the board. Also Preferred Developments submitted a site plan. The board approved the plan with some additions that needed to be added to the plans and upon approval of the drain commission.
