1. Call to Order

- A. County Commissioner, Scott Beltman, gave a report:
 - a. Broadband for the County is in the works. They have submitted to the State for the ROBIN grant.

 - c. Resolution on Poverty Exemption Income Guidelines and Asset Test, Following the Federal Government Guidelines. Motion from Lindholm with support from Boerman to adopt Resolution. Roll call vote: Ayes: Jones, M.Harvey, Lindholm, Boerman, B.Harvey. Nay: None. Resolution adopted.
- C. Motion from Boerman with support from B.Harvey to adopt Ordinance 041023-1 Addressing Floodplain Management Provisions of the State Construction Code and adopting the FEMA maps dated June 21, 2023. This Ordinance will replace Ordinance 98. Vote taken, all in favor, Ordinance adopted.
- D. Ruth Tidd, Lynn Bosch and Duane Joostberns approached the Board asking for space to store memorabilia from the Hamilton Historical Society at the Township Hall. The Board discussed this and offered space in the basement, which is climate controlled and clean. Both groups were happy with this arrangement and the Historical Society will work during office hours to move in.
