### 2021 Annual Report

January 31st, 2022

As of December 31<sup>st</sup>, 2021, Hamilton Fire & Rescue has responded to 509 incidents for the year. In comparison to 462 incidents for 2020, we are showing a 10 % increase in incident call volume. A record number of incidents in a 24 hour period was 21, which occurred on August 8, 2021.

The Operational Budget Expenses, (Less Capital Equipment) for the first six months of the 2021/2022 fiscal year is \$240,966.86, or 45.5 %, of the Approved 2021/2022 Operational Budget.

Our call volume has increased 10 %, above last year, while the Operational Budget is averaging 4.5 % below projections, to date.

A few weeks ago we met with a vendor for the purchasing of the new SCBA Air Packs. During the conversation they commented how other fire departments have been repurchasing Air Packs, through the FEMA Grant. We stated that Hamilton has applied three times for the FEMA Grant, and has been turned down each time. We were told that you can't get a second grant for the same equipment. The vendor stated that other fire departments have gotten a second SCBA Grant, due to the fact that the SCBA NFPA Standards have changed. The vendor went on to say that there must be something wrong with our grant, review it, and resubmit it.

We reach out to Assistant Chief Chris Mantels, Saugatuck Fire Department, who has been awarded a number of FEMA Grants, to review our past grants. Assistant Chief Mantels did find areas in our past grant that needed to be corrected and improved.

Assistant Chief Mantels has agreed to rewrite our FEMA SCBA Grant and submit it on our behalf. The resubmitted grant will be for \$187,578.00.

Therefore, we will be pushing the Capital Equipment Request item of \$69,550.00, for SCBA Air Packs, from the 2020/2021 Fiscal Year Capital Equipment Budget, to the 2021/2022 Fiscal Years Capital Equipment Budget Request.

If, we are successful in being awarded a FEMA SCBA Grant in the 2021/2022 Fiscal Year, part of the \$69,550.00 would be used as the grant match, an estimated \$9,500.00. The balance of the estimated \$60,050.00 would then be a refund to the townships.

In the past year we have completed 16 hours of Medical Continuing Education, and 36 hours of Fire Continuing Education.

The jointly owned Live Fire Training Facility, in Saugatuck, is a huge asset for our continuing fire training.

At our recent Live Fire Training Facility board meeting, it was agreed to make an estimated \$12,000.00 worth of improvements to the facility.

Congrats to F/F Dillon Vander Kamp in his completion and certification of his EMT license.

Hamilton Fire & Rescue was awarded a \$4,896.00 Safety Grant from the Michigan Township Participating Plan. Back Road Services has installed reflective chevron striping on the rear of our fire apparatus.

In 2021, we once again started our Fire Safety Program for our youth. Seven programs where presented, reaching 175 children.

After the wind storm this past August, power was out for several area residents, including the fire station. The fire station however, has a backup generator. The word soon spread the fire station had water. Soon after we started filling water jugs for people.

Our incident volume and training requirements continue to increase. The average Firefighter with Hamilton Fire & Rescue will spend approximately 750 to 650 hours on duty, and or in service for our community. Hamilton Fire & Rescue is very blessed to have a great group of multitalented Firefighters, who will answer the call on the stormiest days and darkest nights, without question.

The success of Hamilton Fire & Rescue is a direct reflection of the people who have and continue to step forward to serve our community. Our community leaders, and most importantly, the overwhelming support of our community.
