

Tompkins Township
Minutes
June 6, 2006

The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. in the township hall by Supervisor John Tuttle. Members present in addition to the supervisor were Clerk Melanie Curran, Treasurer Linda Sterrett, Trustee Nancy Seydell, and Trustee Gary Purcell. The minutes of the **April 22, 2006 Special Meeting Minutes** submitted by Nancy L. Stewart Property Lease - Moved by Sterrett to approve the farm land lease, seconded by Seydell. Roll call yes votes: Curran, Seydell, Purcell, Sterrett, and Tuttle. No votes: none. Motion carried.

Historical Donation to Cemeteries - Moved by Tuttle to give \$500.00 each to Fairview and Pope Church Cemetery for upkeep and maintenance as requested by the cemeteries, and to preapprove payment, seconded by Seydell. Roll call yes votes: Curran, Seydell, Purcell, Sterrett, and Tuttle. No votes: none. Motion carried.

Zoning Ordinance to Ken Sparks, Attorney - Moved by Curran to request Ken Sparks, Attorney to review the zoning ordinance for changes due to recent legislation as needed and update the table of contents, seconded by Sterrett. Roll call yes votes: Curran, Seydell, Purcell, Sterrett, and Tuttle. No votes: none. Motion carried.

Waive Township First Right of Refusal to purchase all parcels of property that were foreclosed upon in March of 2006. Moved by Curran, seconded by Sterrett. Motion carried.

Grant for VAT (Voter Assist Terminal) Equipment for Elections - Permission to request grant from the State of Michigan for election equipment by the Clerk. Moved by Curran, seconded by Sterrett. Roll call all yes. Motion carried.

Public Comment was opened at 8:00 p.m. Comments were received and the meeting continued.

Two building permits were read by the Supervisor.

The meeting was adjourned at 8:22 p.m. with nine in attendance.
