Minutes

March 6, 2007

The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. in the township hall by Supervisor John Tuttle. Members present in addition to the Supervisor were Clerk Melanie Curran, and Treasurer Linda Sterrett. Trustee Gary Purcell and Trustee Nancy Seydell. The minutes of the **February 6, 2007 Regular Meeting Minutes were approved** following a motion by Seydell, seconded by Sterrett. **Treasurer's report** was read as: Disbursements of \$22,147.75, deposits of \$32,668.02, and a balance of \$142,519.19. The report was approved following a motion by Seydell, seconded by Purcell. **Moved to Amend the Budget:** Sterrett moved to amend the Township Board account \$9500.00 by taking \$4000.00 from Township Hall account and \$4500.00 from Roads, second by Purcell. Roll call yes votes: all. No votes: none. Motion carried. Moved to amend the Treasurer Account by \$1000.00 from Fire Protection by Curran, second by Purcell. Roll call yes votes: all. No votes: none. Motion carried. **Vouchers for the fire department** bills were read. Moved to accept the vouchers by Tuttle, seconded by Sterrett. Voice vote: No vote noted from Sedyell. Motion carried.
