May 1, 2007

The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. in the township hall by Supervisor John Tuttle. Members present in addition to the Supervisor were Clerk Melanie Curran, and Treasurer Linda Sterrett. Trustee Gary Purcell and Trustee Nancy Seydell. Fire Committee: Moved by Tuttle, seconded by Seydell to change the Rives Tompkins Fire Dept. SOG to allow the Fire Committee to hire, fire, and discipline all personnel for a maximum of six months. Roll call yes votes: Seydell, Sterrett, Tuttle, and Curran. No votes: Purcell. Motion carried.

Cemeteries Request Funds: Submitted by Pope Cemetery and Tompkins Cemetery a request for \$500.00. Moved to promote the historical qualities and make a historical donation to Pope Cemetery and Tompkins Cemetery by Curran, seconded by Sterrett. Roll call: all yes. Motion carried.

Prepay Pope Cemetery, Tompkins Cemetery, Performance Automotive: Moved by Curran, seconded by Purcell to prepay Pope Cemetery, Tompkins Cemetery and Performance Automotive \$31.93 for a mower part. Roll call votes: all yes. Motion carried.

Five Year Local Road Construction Program: Moved to approve the 5 Year Local Road Construction Program for Tompkins Township as proposed by Sterrett, seconded by Purcell. Roll call votes: all yes. Motion carried.

Tractor Tires: Moved by Curran to fill the tractor tires with chloride and prepay the bill (approx. \$177.36), seconded by Seydell. Roll call votes: all yes. Motion carried.

Public Comment was opened at 8:20 p.m. with no comments received and the meeting continued.

Two building permits were read by the Supervisor.
The meeting was adjourned at 8:25 p.m. with five in attendance.
