Minutes
October 3, 2006

The regular meeting of the Tompkins Township Board was called to order at 7:00 p.m. in the township hall by Supervisor John Tuttle. Members present in addition to the Supervisor were Clerk Melanie Curran, Treasurer Linda Sterrett, Trustee Nancy Seydell, and Trustee Gary Purcell. The minutes of the **September 5, 2006 Regular Meeting Minutes were approved** following a motion by Seydell, seconded by Sterrett. **Treasurer's report** was read as: Disbursements of \$13,927.14, deposits of \$9,445.74, and a balance of \$149,613.73. The report was approved following a motion by Seydell, seconded by Purcell. **Vouchers for the fire department bills** were read. Moved to accept the vouchers by Sterrett, seconded by Purcell. Motion carried.

Re-State Tompkins Township Board Position regarding Agriculture Preservation -

Regarding the Agriculture Preservation Program the Township Board has discussed the topic and has decided to participate and support the program with the understanding there is no financial obligation to the township by Tuttle, second by Sterrett. Motion carried.

Addressing for the Township - In regards to the new ordinance passed by the county requiring the township to assign addresses as needed it was moved by Tuttle to assign the duty of addressing to the Zoning Administrator, second by Sterrett. Motion carried.

Addressing Application - Tompkins Township shall use a pattern of Rives Township Address Application, \$ 20.00 fee for numbering and \$20.00 fee for a green address sign, motion by Tuttle, second by Seydell. Roll call yes votes: Tuttle, Curran, Seydell, Purcell, and Sterrett. No votes: none. Motion carried.

Stewart Property Building - Moved to demolish a specific building noted on the Stewart Property and follow through with insurance removal and as needed replacement by Curran, second by Purcell. Roll call yes votes: Tuttle, Curran, Seydell, Purcell, and Sterrett. No votes: none. Motion carried.

Region 2 Planning Commission - Moved by Seydell, second by Tuttle to approve membership to Region 2 Planning Commission for the next year and prepay \$744.66 membership dues. Roll call yes votes: Tuttle, Curran, Seydell, Purcell, and Sterrett. No votes: none.

Authorize Dick Frizzle, Fire Chief to receive bids and sell two fire trucks - Motion by Tuttle, second by Curran. Roll call yes votes: Tuttle, Curran, Seydell, Purcell, and Sterrett. No votes: none. Motion carried.

Public Comment was opened at 8:50 p.m. Comments were received and the meeting continued.

Three building permits were read by the Supervisor.

The meeting was adjourned at 8:53 p.m. with six in attendance.
