#### WEIAUSA ENTRY AGREEMENT

By entering a WEIAUSA-licensed Competition and signing this entry blank as the Rider and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The Working Equitation International Association of the Unites States of America (the "Group") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the WEIAUSA and the competition, including the WEIAUSA Code of Conduct. I will accept as final the decision of the competition officials on any question arising under the Rules, and agree to release and hold harmless the competition, the Group, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Group and/or the competition may use or assign photographs, videos, audios, cable-casts, or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Group. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Group rules are governed by the State of Texas, and any action instituted against the Group must be filed in Texas.

# <u>WEIAUSA Release, Assumption of Risk, Waiver, and Indemnification</u> This document waives important legal rights. Read it carefully before signing.

I AGEE in consideration for my participation in this Competition to the following:

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, owner, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").

I AGREE to release the WEIAUSA and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Group or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Group or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Group and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition. I understand that I am entitled to wear protective equipment without penalty.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to assume all of the obligations of this Release on the child's behalf.

I AGREE that "the Group" and "Competition" as used above includes all of the officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.

I AGREE that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the WEIAUSA on the official WEIAUSA accident/injury report form.

I represent that I have the requisite training, coaching and abilities to safely compete in this competition. **BY SIGNING BELOW, I AGREE** to be bound by all applicable WEIAUSA Rules and all terms and provisions of this entry blank.
